KNOW ALL MEN BY THESE PRESENT

That we, the undersigned, of Pierce County, in the State of Washington, and citizens of the United States and the State of Washington, do hereby associate ourselves together with the intention of forming a corporation, and do hereby form a corporation for the purpose hereinafter specified under the laws of the State of Washington relating to social, charitable and educational corporations. (Chap. CLVIII. Laws of 1895, Sections 24.16.010 to 24.16.140 of the Revised Code of Washington).

ARTICLE I

The name of this corporation shall be the KEY PENNINSULA CIVIC CENTER ASSOCIATION, INC.

ARTICLE II

The location and principle place of business of this corporation shall be at Vaughn, Washington.

ARTICLE III

This corporation is formed exclusively for the following purposes:

- (a) To render constructive civic services to the public for the promotion of the welfare of the community and of the citizens of the Key Peninsula of Pierce County, Washington, and the area surrounding the same, to inculcate civic consciousness by means of active participation in constructive projects which will improve the community, state and nation. The purpose of the proposed corporation shall not be the protection, promotion or stimulation of any business organized for profit or political ideology. Revised by the Board of Trustees Feb. 12, 1976.
- (b) To foster, protect and promote charitable, literary, youth, educational, civic and public interest of the Key Peninsula and the area immediately surrounding it, all in the State of Washington. Revised by the Board of Trustees Feb. 12, 1976.
- (c) To gather, sequire, compile, preserve and disseminate statistics and information concerning the charitable, literary, youth, educational, civic and public interest of the Key Peninsula and the area immediately surrounding the same and State of Washington. Revised by the Roard of Trustees Feb. 12, 1976.
- (d) To provide an exchange or meeting place for the members of this organization and to arrange membership meeting for social, charitable, literary, youth and educational purposes. Revised by the Board of Trustees Feb. 12, 1976.
- (a) To foster such social, youth, educational, civic, literary and charitable projects and activities as will, in the opinion of its members, result in the improvement of the Key Peninsula and the immediate surrounding area and State of Washington, and to stimulate the interest of its members in such projects and activities. Revised by the Board of Trustees Feb. 12, 1976.
- (f) To do such things that may be necessary, proper or expedient to carry on the objectives and purposes of this corporation.
- (g) The above enumerated purposes shall be in furtherance and not in limitation of the general powers conferred by the laws of the State of Washington upon corporations organized under the provision of law authorizing the forming of this corporation.
- (h) Notwithstanding other provisions of these articles this corporation shall not engage in any activity not permitted to organizations who are exampt from Article 50103. Added by the Board of Trustees Feb. 12, 1976.

ARTICLE IV

Upon the dissolution of the Corporation, the Board of Trustees shall, after paying or making provision for the payment of all of the liabilities of this corporation, shall dispose of all other assets of this Corporation to the Key Peninsula Park and Recreation District, a Municipal Corporation under the laws of the State of Washington. In the event the Key Peninsula Park and Recreation District is unwilling or unable to receive the assets under Article 501C3, the assets would then be distributed by the Superior Court of Pierce County, State of Washington, to meet with 50103 U.S. Internal Revenue Law. Added by the Board of Trustees Feb. 12, 1976.

ARTICLE V

This corporation shall have no capital stock, but members may be admitted to the Corporation upon such terms and conditions and in such numbers, and with such qualifications as may be prescribed by the By-Laws of this corporation to be hereafter adopted.
